

Interim Administrative Rules for the Printing, Casting and Lettering Industry

Article 1 is to strengthen social security, ensure the legal operation of the printing, casting and lettering industry, and prevent forgery and counterfeiting by criminals. These rules are specially formulated.

Article 2 Anyone who operates a foundry, a plate-making agency (manufacturing stencils, copper plates, offset plates, lithographic plates, color plates, fire imprints, zinc imprints, certification marks, etc.), printing offices (printing books, securities, trademarks with mechanical or chemical materials) etc.), badge shops, engraving shops, engraving booths (engraving stamps, printing plates, seals, rubber stamps, etc.) and all businesses of the superior nature, whether franchised, concurrently, public or private, (exceptions are there for state agencies) or unless otherwise stipulated by laws and regulations, it shall be governed by these rules.

Article 3 Anyone who operates a printing, casting and engraving business must first apply for registration to the public security bureau or sub-bureau of the people's government of the city (county), and go through the following procedures:

1. Fill in two copies of the special business registration form in detail, attaching the applicant's most recent two-inch bareheaded photos, and find two reliable non-industry shop guarantees.
2. Make a list of shareholders and employees of the industry, construction equipment and the sketch plan of the surrounding area (plan sketch plan of the open-air lettering booth is exempted from payment).
3. Send the completed application and registration form, together with photos, thumbnails, lists, etc., to the public security bureau or sub-bureau. After approval and issuance of a license, an application must be made to the industry and commerce authority, and business licenses can only be approved after obtaining a business license.

Article 4 Any printing, casting and engraving business that has opened before the promulgation of these rules must complete the procedures specified in Article 3.

Article 5 All licensed printing, casting and engraving operators, if they change their business name, manager, shareholders, or move, expand, change their business, or close their business, must first obtain permission from the Public Security Bureau or branch before they can handle other matters. formalities.

Article 6 Anyone who operates a printing, casting and engraving business must comply with the following matters:

1. In case of any of the following situations of printing and engraving, the prototype and the certification documents of the agency entrusting the printing and engraving must be submitted to the local people's public security agency at any time It can be printed after approval and filing.

Engraving of customs defenses, seals, official seals, official seals, rubber seals, official seals and name seals of the responsible chiefs of agencies, organizations, schools, and public enterprises.

2. Printing notices, passports, letters of appointment, armbands, symbols, badges, securities and clerical letters, etc.

3. Casting various steel seals, fire seals, number plates, badges, etc. used by institutions, organizations, schools, and public enterprises, or imitating such styles.

2. Anyone who operates a printing, casting and engraving business shall prepare a business register for inspection. For all printed products specified in the first paragraph of this article, the manufacturer is not allowed to keep samples, imitate, or reprint without permission.

3. In case of any of the following circumstances, the local people's public security organ must be promptly reported:

1. Forged or counterfeited notices, passports, letters of appointment, armbands, symbols, badges, securities and documents of various agencies, etc.

2. Privately customizing the steel seals, fire seals, badges, certificates, number plates or imitations of various agencies, organizations, schools, and public enterprises.

3. In the event of custom-made illegal groups, agency stamps, prints, badges or imitations.

4. Those who print various reactionary printed materials against people's democracy, production and construction, and propaganda of feudalism.

Anyone who prints and casts the items specified in the third paragraph of this article shall be punished according to the seriousness of the circumstances, in addition to confiscation of the raw materials and finished products.

5. Personnel performing inspection duties of the people's public security organs shall be assisted.

Article 7 When a business operator falls under any of the following circumstances, it may cancel its special business license and suspend its business operation.

1. Those who use the name of another person.

2. Those who have not started business for more than two months without justifiable reasons after obtaining the license.

3. Those who have suspended work for more than one month without any reason.

4. The whereabouts of the business operator are unknown for more than two months.

Article 8 Anyone who reports and reports in accordance with the provisions of these rules, and thus finds major criminals and solves major cases, will be given honorary or material rewards by the Public Security Bureau as appropriate.

Article 9 The people's public security organs at or above the provincial level may formulate supplementary measures in accordance with the spirit of these regulations; if the county (city) level people's public security organs need to formulate supplementary measures, they must be approved by the provincial-level people's public security organs.

Article 10 These rules are approved by the Political and Legal Committee of the Central People's Government Administration Council, and issued and implemented by the Ministry of Public Security of the Central People's Government.
